The College was established in the year 2017. It has given students an opportunity to study various aspects of Indian and International legal principles and jurisprudence. Our endeavour is to see that the students are equipped with sound ethical principles while acquiring legal knowledge.

While the college admits students without distinction of gender, caste and creed, preference is given to students who hail from the minority communities and women who are traditionally underrepresented in the legal profession. The college also admits students from other professional backgrounds who intend to take up law as a second profession.

This college provides a great opportunity for those who are interested in learning legal principles for an academic and legal career and those who want to fight for justice in the society.

## COURSES

The college offers different courses leading to the following degrees of Karnataka State Law University, Hubballi.

- \* LL.B (3 YEARS) Course : The duration of the programme is three academic years consisting of 6 semesters of 18 weeks each. (Eligibility any degree)
- \* BA, LL.B (5 YEARS INTEGRATED DEGREE) Course : The duration of the programme is five academic years comprising of 10 semesters of 18 weeks each. (Eligibility PUC/12 Std.)
- \* BBA, LL.B (5 YEARS INTEGRATED DEGREE) comprising of 10 semesters of 18 weeks each. (Eligibility PUC/12 Std.)
- \* BCom, LL.B (5 YEARS INTEGRATED DEGREE) Course: The duration of the programme is five academic years comprising of 10 semesters of 18 weeks each. (Eligibility PUC/12 Std.)

## ELIGIBILITY FOR FIVE YEAR INTEGRATED COURSE

Admissions to first year of the 5 years BA, LL. B / BBA, LL. B / BCom, LL. B integrated course, in all colleges under the jurisdiction of Karnataka State Law University, is strictly based on merit, based on the marks secured by the candidate in the qualifying examination.

To be eligible for admission in the 5-year BA, LL. B / BBA, LL. B / BCom, LL. B integrated course, the candidate should:

Have successfully completed Pre-University course or Senior Secondary School course ('+ 2') or equivalent such as (11 + 1, 'A' level in Senior School Leaving Certificate course) from a recognized University of India or outside or from Senior Secondary Board or equivalent, constituted or recognized by the Union or by the State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted to the course.

Applicants who have obtained +2 Higher Secondary Pass Certificate or First-Degree Certificate after pursuing studies in distance or correspondence method shall also be considered as eligible for admission to the course.

Applicants who have obtained 10+2 or graduation or post-graduation through Open Universities system directly without having any basic qualification for pursuing such studies are not eligible for admission to the course.

## ELIGIBILITY FOR THREE YEAR LL. B COURSE

Admission to first year of the 3-year LL. B course, in all colleges under the jurisdiction of Karnataka State Law University, is strictly based on merit, based on the marks secured by the candidate in the qualifying examination.

To be eligible for admission to the 3-year LL. B course, the candidate should:

Have graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for three year degree course in law leading to the conferment of LL.B. degree on successful completion of the regular programme conducted under these regulations.

## HOW TO APPLY

Eligible candidates may register themselves on the college website [www.sjcl.edu.in](http://www.sjcl.edu.in) along with a Registration Fee(non-refundable) of Rs. 1,000/-.

## ADMISSION PROCESS

### APPLICATIONS:

- Applications for the 5-year integrated courses (BALLB, BBALLB, BCOMLLB) and the 3-year LLB programme can be successfully submitted by:
- Registering themselves in the College Admission portal with name, email address, mobile number, date of birth.
- Fill the application form with relevant details and upload the following documents.
  - Photograph (formal passport size photo with white background)
  - SSLC / 10th Standard mark sheet.
  - 11th Standard mark sheet
  - 2nd PUC / 12th Standard mark sheet
  - Caste certificate
  - Letter from Parish Priest (for Christian students only)
  - Pay the required application fees of Rs. 1000/-

### ON SUBMISSION AND PAYMENT OF THE APPLICATION FEE:

- The applicant will receive an automated confirmation mail.
- Shortlisted candidates will be informed regarding offline entrance examinations. The exam dates will be informed one week in advance to outstation candidates.
- The entrance examination will be followed by a 2-step interview process.
- The entrance examination will be for total of 50 marks for a duration of 1 hour.
- Questions will be in the form of MCQS.
- The major components of the examination are legal aptitude, analogy, current affairs, English language.
- Shortlisted students will be intimated regarding their selection via mail.
- The College does not have any middlemen, agents for the admission process. No donations/ capitation fees or recommendations will be accepted by the College.

## ELIGIBILITY CERTIFICATE

Applicants who have passed the qualifying examination from Universities other than those located in Karnataka State / Karnataka PU Board / CBSE must produce the Eligibility Certificate issued by the Registrar, Karnataka State Law University, Hubballi. This certificate can be obtained from the University on submitting an application in the prescribed form by enclosing the attested photocopies of the statement of marks, Migration certificate along with the fees prescribed by the Registrar, Karnataka State Law University, Hubballi. No admission can be made in the college without this eligibility certificate.

## MIGRATION CERTIFICATE

All the students who have studied courses other than that of Pre-University Board of Karnataka and students who have completed degree course shall produce Migration Certificate.

## Add on programmes

The college offers add on courses that supplement the curriculum and enhance the study of law. Certificate courses, student development programmes, seminars, workshops touching various facets of law are organised on a regular basis. ## Placement and Internships

Acting on the mandate of the Karnataka State Law University students are expected to complete 20 weeks of internship (for the 5-year integrated law course), 12 weeks of internship (for the 3-year LLB programme). Placement opportunities facilitated by the college for those students who fulfil the eligibility criteria

## Library

The library resources are constantly updated with current publications. It has a large collection of text books, reference books and multimedia, which are continuously updated with the latest editions. The college subscribes to national and international periodicals, databases and online journals. Students can access online databases, journals and catalogues of library. The digital section of the library provides collection of full text of documents and faculty publications. There is ample reading room space both inside as well as outside the library.

## Moot Court

In order to become a successful legal professional, it is essential for a student to know how to apply the law to actual situations and to have awareness of the rules and the etiquettes of the Court. The Moot Court Society of SJCL actively organises various mooting events for students throughout the year. Our students have represented the College at national and International Moot competitions, trial advocacy competitions and client counselling events.

## Research

The Research Committee aims at strengthening research initiatives both inside and outside the College. Workshops, journal publications, seminars, conferences are organised on a regular basis to promote, hone and encourage research culture amongst the students.

## Counselling

Personal and non-academic counselling is provided by a trained counsellor to help and motivate the students. A full time counsellor on campus helps to maintain and enhance the psychological, emotional and relational wellbeing of the students. Consultations with the counsellor are treated with sensitivity, care and confidentiality.
